**JUNIOR CAMPUS or TEEN CAMPUS:** Campers who are 1) Entering 8<sup>th</sup> grade in September 2026 and 2) Age 13 before arriving at camp are eligible to reside on either Junior Campus or Teen Campus. If your child meets these 2 conditions, indicate which Campus you prefer.

**CAMP TUITION** - A deposit of \$500 is required to process each enrollment application. Your next payment of \$500 is due on or before February 1<sup>st</sup>. Your final balance is due on or before May 1<sup>st</sup> of the current camping season. Accounts that are delinquent after the February 1<sup>st</sup> deadline or May 1<sup>st</sup> deadline will forfeit all tuition discounts (sibling credits & early registration credits) and may be cancelled at the discretion of the camp. The camp tuition includes: board, lodging, camp nursing care (except lice treatments), program supplies (few exceptions), and activities (except 'optional programs').

SIBLING CREDIT - Cayuga extends a discount to families who enroll 2 or more children. The tuition is credited \$400 for each additional sibling enrolled for the full-season and \$300, \$200, and \$100 for the 6-week session, half session, and 2-week session respectively. The shorter session is used to determine the credit. There is no sibling credit for a stay less than 2 weeks.

**CANTEEN FEE** - The canteen fee is the only mandatory charge in addition to the camp tuition. The canteen fee is \$390 (full-season); \$300 (6-week session); \$210 (half-session); \$120 (2-week session). The canteen fee covers: one official Camp Cayuga t-shirt; weekly laundry service; daily snack allowance; and off-season mailings. Since the total cost of the canteen items exceeds the amount charged, there is never a prorated refund of the canteen fee. Do not confuse the canteen fee with your camper's *Camp Bank*, which holds your child's 'spending money' for personal expenditures and nominal day-trip fees.

**REFUND OF PAYMENTS** - FOR FIRST TIME CAYUGA CAMPERS: Campers enrolling for their first summer are extended Cayuga's *First-Time Camper Guarantee*, which provides a refund of the camp tuition for the days not attended by the camper due to an early departure. The parent must abide by the camp policies regarding early departure procedures for the *First-Time Camper Guarantee* to apply. Tuition refunds are based upon the actual session the camper attends camp. Example: If a camper enrolls for the fullseason and departs camp at the end of the first-half session, the first-half session tuition is charged (not one-half of the full-season tuition).

FOR RETURNING CAMPERS: No tuition refund is granted when a returning camper departs camp with 14 days or less remaining in the camper's enrolled session. If a returning camper departs camp with 15 days or more remaining in the original enrolled session, the camp will refund one-half of the tuition balance after deducting the ordinary charges for the period the child remained in camp. Example #1: If a camper enrolls for the full-season and departs at the end of the first-half session, the charge is the first-half session tuition plus one-half the difference between the full-season tuition (original session) and the first-half tuition (new session). Example #2: If a camper enrolls in the first-half session (28 days) and departs on the 11th day, the charge is the first 2-week session tuition prorated for 11 days plus one-half the difference between the first-half tuition (original session) and the first 2-week tuition prorated for 11 days (new session). Example #3: If a camper enrolls in a 2-week session and departs before the end of the session, the charge remains the same. There is no refund when a returning camper departs camp with 14 days or less remaining in the camper's enrolled session.

FOR ALL CAMPERS: Refunds are mailed after the camp season but before September 30<sup>th</sup>. Tuition fees and refunds are based upon the actual session(s) the camper attends camp. Any discounts and/or credits relating to the actual session are applied. If a camper arrives late to camp, no tuition credit or canteen credit is given for the missed days. Cayuga reserves the unrestricted right to dismiss, without a refund, any camper who exhibits emotional, psychological or behavioral conditions that are disruptive to the camp program or that are harmful to himself or the well being of other campers or staff.

**CANCELLATIONS** - Cancellations received on or before April 30<sup>th</sup> incur a \$250 fee. Enrollments cancelled after April 30<sup>th</sup> incur a \$500 fee. All remaining payments will be refunded.

**TREATMENT AUTHORIZATION AND INSURANCE** - Campers are required to carry health insurance. Certain illnesses or injuries are referred to noncamp medical professionals whose fees are not covered by the camp tuition. If it is necessary, in the judgment of the Camp Director, to use outside medical, surgical, or dental aid for the camper's health, the parent(s) or legal guardian hereby authorizes him to obtain this medical care and further agrees to pay for the medical services provided whether or not the medical expense is covered by the parent's or legal guardian's insurance policy.

**OPTIONAL LINEN RENTAL SERVICE** - This service includes sheets, pillowcases, and blankets. Pillows, towels, and washcloths are not included and need to be provided by the camper. The charge for this optional service is \$140 (full-season), \$105 (6-week session), \$70 (half-session), and \$35 (2-week session). There is no prorated refund for this service if a camper arrives late or departs early from camp. Note: The weekly laundering of all linens (and clothing) is included in the Canteen Fee.

**OPTIONAL BUS AND BAGGAGE SERVICE** - Camp Cayuga provides bus transportation and baggage service 4 times during the camp season: 1) To camp on opening day (Sunday, 6/28/26); 2) To camp on the start date for the second-half & third 2-week session (Sunday, 7/26/26); 3) From camp at the end of first-half session & second 2-week session (Saturday, 7/25/26); 4) From camp at the end of the summer (Saturday, 8/22/26). This service caters to families who reside in the New York area. The charge for this optional service is \$125 one-way (or \$250 roundtrip).

**OPTIONAL SPECIAL AIRPORT TRANSPORTATION SERVICE** - Cayuga provides transportation to/from 3 airports on the first & last day of each session. A Senior Staff Member will personally escort your child to/from the terminal gate. The <u>roundtrip</u> charge per child is \$140 (\$70 one-way) for Scranton Wilkesbarre Airport (Avoca, Pennsylvania), \$240 (\$120 one-way) for Newark International Airport (New Jersey), and \$280 (\$140 one-way) for JFK International Airport (Jamaica, New York). We discourage JFK Airport for travel-time purposes. If the flight date is scheduled on any date other than an official camp session date, an extra fee will be added as follows: Newark Airport (extra \$55 one-way) and JFK Airport (extra \$55 one-way). <u>Before</u> making your flight arrangements, cead the *Airport Transportation Instructions*. <u>After</u> making your flight arrangements, complete the *Airport Transportation Itinerary Form.* These forms are accessible on Cayuga's website (See 'Optional Services').

**OPTIONAL PROGRAMS: PRIVATE TENNIS LESSONS, ATVs, ACADEMIC TUTORING, PAINTBALL, SCUBA DIVING CLINIC, SURVIVAL CLINIC** - These programs are not included in the tuition. Advance registration is required. You can register with this paper application or from your online account up until arrival day. Thereafter, registration is closed and not available. If spaces become available for the clinics, campers will be able to sign-up at camp.

**CONDITIONS OF ENROLLMENT** - Camp Cayuga strives to provide positive camp experiences for children with various needs whenever possible. However, Camp Cayuga does not provide programs that are rehabilitative or therapeutic in nature, and does not specialize in serving children with special needs, including children with emotional, social, or behavioral difficulties. Please provide information (attach a separate sheet) regarding your child's special needs, including any disabilities, disorders or medical problems with this application form. It is important to determine if the Camp Cayuga experience is appropriate for your child prior to attending camp. Failure to provide adequate information prior to your child attending camp may result in the camper being sent home without a refund. Cayuga cannot accept children who do not have the promise of living cooperatively with others.

I hereby assume these risks and agree to hold harmless and hereby release, discharge and agree to indemnify Camp Cayuga, its directors, owners, agents, and employees from all liability for loss, damage, injury or illness to the camper or camper's property related to his/her participation in the camp program.

\* I have also instructed my child in the importance of knowing & abiding by the camp's rules and regulations, and my child has agreed to do so. This includes attending scheduled activities, as well as wearing appropriate clothing at all times. Inappropriate clothing is defined as provocative dress, such as transparent/sheer clothing, cropped tops, cheeky swimsuit bottoms/string bikinis, speedos, short shorts, and the like. These items will be confiscated.
