All campers are eligible to participate in the ATV Quad Riding Program subject to an evaluation of the camper's physical and mental maturity, which is performed by our Quad Instructors during your child's first session. There are no age restrictions. Cayuga's Quad Riding Program features child-size Suzuki 4-wheelers in two different sizes to accommodate both young and older children. ATV Quad Riding is an optional activity that's not included in the camp tuition. The extra program fee is \$50 per 50-minute period. Advance registration is required. Any number of sessions can be requested. If we can't accommodate the number you requested, we'll send you a refund for the unused paid sessions.

SAFETY TEST: Campers will be given a Safety Control Test to determine their ability to manage the quad and understand its operation. If the Quad Instructors determine your child can safely operate the quad, he/she will be scheduled this activity. If your camper is evaluated as being unable to control the quad, all remaining fees paid for Quad Riding will be fully refunded. Quad riders must wear long pants and boots. The camp provides the safety equipment including helmet, goggles, and safety pads.

ATV QUAD RIDING ACTIVITY RELEASE FORM

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of permitting my child to participate in the quad riding activity conducted at Camp Cayuga I, for myself and on behalf of my child, my personal representatives, heirs and next of kin do the following:

I hereby acknowledge that quad riding is a potentially dangerous activity and involves the risk of serious injury and/or death and/or property damage. While particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist.

I fully understand and acknowledge that: (a) risks and dangers exist in my child's operation of a quad, (b) my child's participation in such activities and/or use of a quad may result in injury or damage to personal property including the potential for permanent disability and death, (c) these risks and dangers may be caused by the quad activity operator, camp staff members or other participants, or by accidents, or by forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including but not limited to, selection of quad track, trail or uneven terrain, weather conditions, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

I understand that the activity of quad riding is physically and mentally intense. I have instructed my child in the importance of knowing and adhering to the rules, regulations and procedures established for the safety of quad riding participants and my child has agreed to do so.

I hereby release, waive and discharge Camp Cayuga, its owners, directors, officers, employees and agents (the Releasees) from all liability to myself or my child, my personal representatives, all assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands thereon on account of injury and/or death to my child and/or property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities or any other related to quad riding operations that may occur, whether caused by the negligence of the releasees or otherwise.

I hereby assume full responsibility for any risk of bodily injury, death or property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any related quad riding operation, whether foreseen or unforeseen and whether caused by the negligence of the Releasees or otherwise. I hereby separately agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost that they may incur, now and forever, arising out of or related to my child's participation and/or instruction in said course, activities, or any other related quad riding operations, whether caused by the negligence of the Releasees or otherwise.

I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held valid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.

I have read this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me or my child & intend my signature to be a complete & unconditional release of all liability to the greatest extent allowed by law.

As a parent or guardian with legal responsibility for this participant, acknowledge that I am signing this document on behalf of my minor child and agree to be specifically bound to all of the terms and conditions of this agreement. I have read the agreement, fully understand the terms therein, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed this document freely and voluntarily without any inducement, assurance or guarantee being made to me. I intend my signature to be complete and unconditional release of all liability to the greatest extent allowed by law and further agree to indemnify and save and hold harmless the Releasees.
