The Paintball Activity is offered to campers entering the 5th grade & higher. This optional activity is not included in the camp tuition. Advance registration is required. The extra program fee is \$62 for 2-hour session. Games are conducted on Cayuga's paintball field that features a variety of terrain including natural and man-made obstacles. A facemask and 300 paintballs are provided. Campers are required to wear long pants, long-sleeve shirt, and sneakers. Safety rules are reviewed and practiced before each session.

IMPORTANT: This activity takes place during the daily activity program, and is assigned by our program staff. Your child is required to attend when scheduled. If your camper does not attend, the activity will NOT be rescheduled and NO refund will be given. Please emphasize the importance of attendance to your child. Two exceptions: 1) This activity will be rescheduled if the camper is medically excused or the activity is cancelled (inclement weather); 2) A refund will be provided if the camper was never scheduled to attend.

TO REGISTER: Login to your account, go to 'Forms & Documents' on your dashboard, click 'Additional Options', then click 'Optional Programs' and select 'Paintball'. This online feature will be turned-off within one week of your camper's arrival. At that time, you will need to complete this paper registration form. To return this form, please upload.

If a two-week camper registers for 4 paintball sessons, (2 weeks x 2 times = 4 max), no other optional activities are available. Note: Optional 'clinics' (scuba & survival) are treated differently and have no set limits.

PAINTBALL RELEASE FORM WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of permitting my child to participate in any way in the sport and activity of paintball under the auspices of Camp Cayuga and the American Paintball league, I acknowledge, appreciate and agree that:

The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize the risk, the risk of serious injury does exist.

I fully understand and actional injury decardate. I fully understand and actionowledge that: (a) risks and dangers exist in my child's participation in paintball activities and my child's use of paintball equipment; (b) my child's participation in such activities and/or use of such equipment may result in injury or damage to personal property including the potential for permanent disability and death, (c) these risks and dangers may be caused by the paintball activity operator, camp staff members or other participants, or by accidents, or by the forces of nature or other causes. Risks and dangers may arise from foreseable and unforeseeable causes including, but not limited to, selection of trail or uneven terrain on the playing field, weather conditions, injuries and/or welts or bruises caused by the paintballs, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my child's participation

I understand that the activities of paintball are physically and mentally intense. I understand that the rules of play will be reviewed with my child during the safety orientation class. I have instructed my child in the importance of knowing and abiding by the rules, regulations and procedures established for the safety of paintball participants and my child and along by the face, regulation and proceeded statistication in the statisty of participants and my units has agreed to do so. I have further instructed my child to bring to the attention of the nearest paintball instructor any unusual or unnecessary hazard observed during his/her participation in the activity.

My child is in good health. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems which will present any risk to his/her participation in activities I hereby certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree not only to

his/her release of the American Paintball League, Camp Cayuga, and all other Releasees from any and all liabilities incident to his/her involvement in these programs for myself, my heirs, assigns, and next to kin. I understand and agree that this agreement covers each and every paintball activity and event in which my child

participates hereafter.

I, myself, and on behalf of my heirs, assigns, personal representatives and next to kin on behalf of my child, hereby release, discharge and agree to hold harmless from liability the American Paintball League, Camp Cayuga, its owners, directors, officers, employees and agents (the Releases), with respect to any and all injury, disability, death, or loss or dnamage to person or property, whether caused by the negligence of the releases or otherwise, except that which is the result of gross negligence and/or wanton misconduct.
