The Paintball Activity is available to campers entering the 5th grade or higher. This optional activity is not included in the camp tuition. The extra program fee is \$40 per session. Each session is about 2 hours which is enough time for 3 or 4 games. Campers receive a minimum of 300 paintballs per session. Safety rules and regulations are reviewed & practiced before each game. A facemask is provided by the camp and is worn at all times. Games are conducted on Cayuga's paintball field which features a variety of terrain with natural and man-made obstacles. Any number of sessions can be requested. If we can't accommodate the number you requested, we'll send you a refund for the unused paid sessions.

PAINTBALL RELEASE FORM

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of permitting my child to participate in any way in the sport and activity of paintball under the auspices of Camp Cayuga and the American Paintball league, I acknowledge, appreciate and agree that:

The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize the risk, the risk of serious injury does exist.

I fully understand and acknowledge that: (a) risks and dangers exist in my child's participation in paintball activities and my child's use of paintball equipment; (b) my child's participation in such activities and/or use of such equipment may result in injury or damage to personal property including the potential for permanent disability and death, (c) these risks and dangers may be caused by the paintball activity operator, camp staff members or other participants, or by accidents, or by the forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including, but not limited to, selection of trail or uneven terrain on the playing field, weather conditions, injuries and/or welts or bruises caused by the paintballs, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my child's participation.

I understand that the activities of paintball are physically and mentally intense. I understand that the rules of play will be reviewed with my child during the safety orientation class. I have instructed my child in the importance of knowing and abiding by the rules, regulations and procedures established for the safety of paintball participants and my child has agreed to do so. I have further instructed my child to bring to the attention of the nearest paintball instructor any unusual or unnecessary hazard observed during his/her participation in the activity.

My child is in good health. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems which will present any risk to his/her participation in activities.

I hereby certify that I, as parent/guardian with legal responsibility for this participant, do consent and agree not only to his/her release of the American Paintball League, Camp Cayuga, and all other Releasees from any and all liabilities incident to his/her involvement in these programs for myself, my heirs, assigns, and next to kin.

I understand and agree that this agreement covers each and every paintball activity and event in which my child participates hereafter.

I, myself, and on behalf of my heirs, assigns, personal representatives and next to kin on behalf of my child, hereby release, discharge and agree to hold harmless from liability the American Paintball League, Camp Cayuga, its owners, directors, officers, employees and agents (the Releasees), with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise, except that which is the result of gross negligence and/or wanton misconduct.

I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held valid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.

I have been advised that my child must wear an approved protective face mask which will be provided by Camp Cayuga. No other padding, gloves or clothing is provided. Campers are encouraged to wear long pants and a long sleeved shirt when participating in the activity. It is recommended that boys wear athletic supporters with cups. I also understand and agree that Camp Cayuga will not be held responsible for damages to clothing or personal belongings. (Paintballs are water soluble, biodegradable, and nontoxic.)

I permit the use of any photos, slides, films, videos or sketches of him/her taken during the activity for commercial purposes.

I have read and agree that this Release of Liability Agreement and Assumption of Risk Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
